e) <u>Highway Matters</u>


- ▶ Drains blocked on Spon Lane M White to take up with WCC Highway Officer, Reece Berry.

Response as follows:-

P.27, point 67. The strategic gap must be retained on the North side of the A5. It has already gone on to South side. Tamworth will then take over part of North Warwickshire.

P.35, point 6. Fully support the retention of these areas, especially that of Dordon Hall Lane. It is already blighted by the number of HGV's at the Grendon end as NWBC do not enforce the planning regulations.

P.51, points 166-178. Fully support – Too long has nothing been done regarding traffic/parking in the Long Street area.

The three current Highways proposals for the A5 will not solve it. It will only move the problems to Grendon.

A proper joint solution is needed with National Highways/WCC Highways and NWBC sitting down together and working in concrete.

At present, the A5 proposals are being done on paper in Birmingham by consultants who have not studied the problems in reality and some admitted at the consultation evenings they had never been to Grendon/Dordon before. This is scandalous.
